Entrants may be required to verify they are an active educator at the time of entry with the proper credentials (e.g. teaching certificate, school ID or employee ID).  - **a. Biographical Information:** In no more than two thousand (2,000) characters, describe your teaching career.
 - **b. Narrative:** In no more than three thousand (3,000) characters, describe how you define innovation, how you convey innovation concepts to your students, how your curriculum/module/teaching methodology fits your definition of innovation and inspires creativity, critical thinking a, problem solving or interest in STEM fields.
 - **c.** Curriculum Sample/Lesson Plan: Upload a sample of your curriculum which may be a standards based lesson plan; sample may not exceed five (5) pages. Supported file formats include: .pdf, .doc, .docx, .ppt, .pptx.
 - **d. Classroom Examples:** Upload documentation materials that show us your curriculum in action. These can be presentations, videos, photos, samples of student work, etc. Supporting file formats include: .jpg, .jpeg, .wmf, .pdf, .doc, .docx, .ppt, .pptx, .mp3, .avi, .mp4, .mov, .mpg, .mpeg, and .mpeg2. If providing a video, it must not exceed five (5) minutes in length.
 - **e. Supporting Materials:** Upload supporting materials that may include grant award letters, professional development, previous honors, photos, videos, slideshows, news articles, bulletin board examples relating to innovation, community outreach, school newsletters, letters of recommendation, links to websites that host additional materials, etc. Supporting file formats include: .jpg, .jpeg, .wmf, .pdf, .doc, .docx, .ppt, .pptx, .mp3, .avi, .mp4, .mov, .mpg, .mpeg, and .mpeg2. If providing a video, it must not exceed five (5) minutes in length.

All components of your Submission must be in English. Any entries which include a lesson plan aligned with state and national curriculum standards in any and all subject areas that incorporates digital assets from the available episodes of The Henry Ford's Online Collections will be assessed five (5) bonus points during the judging process as described below. By uploading your Submission, you agree that it conforms to the Submission Content Restrictions as defined below and that Sponsor, may disqualify you from the Contest if it believes, in its sole discretion, that your Submission fails to conform to the Content Restrictions.

Content Restrictions:

- **6. Winner Determination:** After the conclusion of the Contest Period, the Submissions will be judged as outlined below.
 - **a. Initial Judging:** The entire pool of Submissions will be judged by at least two (2) qualified The Henry Ford staff members, determined by Sponsor in its sole discretion. The entrants with the forty (40) highest Submissions will be deemed Semi-Finalists.
 - **b. Semi-Finalist Judging:** The Semi-Finalists' Submissions will be judged by at least two (2) qualified innovative teacher partners, determined by Sponsor in its sole discretion. The Semi-Finalists with the twenty-five (25) highest Submissions will be deemed Finalists.

c. Finalist Judging: The Finalists' Submissions will be judged by at least two (2) qualified outside stakeholders or educational partners, determined by Sponsor in its sole discretion. The Finalists with the ten (10) highest Submissions will be deemed the potential Grand Prize winners; the Finalists with the next ten (10) highest scoring Submissions will be deemed potential First Prize winners.

- Biographical Information/Narrative (25 Points);

- Resourcefulness (20 Points); and
- Positive Impact (20 Points).

In the event of a tie at any point during the judging process, an additional judge determined by Sponsor in its sole discretion will evaluate the tied Submissions based on the Judging Criteria.
