Although this is designed to be a healthy and fun event, it is also beneficial to understand potential risks involved when moving around on bicycles with others in an outdoor and historical environment. Please read this document and provide a copy to your guest(s). By purchasing tickets online you and your guest(s) are agreeing to be bound by these terms.*

## **RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK, INDEMNITY AND/OR PARENTAL CONSENT AGREEMENT**

IN CONSIDERATION of being permitted to participate in any way in the TWILIGHT BIKE RIDE AT GREENFIELD VILLAGE at The Henry Ford, ("Activity"), I, for myself, my guests (and/or on behalf of minors in my charge), my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of bicycling activities and that I am qualified, in good health, and in proper physical condition to participate in this Activity. To the best of my knowledge, my guests and minors in my charge are also in proper physical condition and able to participate in this activity. I further acknowledge that the Activity participation is limited to members of the Henry Ford and their guests. As a member, purchasing these ticket(s) I will provide a copy of this Release to my guest who, by participation, agree to be bound by its terms. Hazards of traveling on a bicycle and riding among other bicyclists are to be expected. We further agree and warrant that if, at any time, we believe the conditions to be unsafe, we will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND that: a) BICYCLING ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("RISKS"); b) these risks may be caused by my own actions or inactions, the actions or inactions of others, and/or the condition in which the Activity takes place; and c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time. WE FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES AND DAMAGES we incur as a result of our participation, and/or that of a minor in the Activity. I/We agree to wear, using our own judgment, appropriate safety gear for our own safety.

3. HEREBY RELEASE, DISCHARGE, HOLD HARMLESS, AGREE TO DEFEND AND INDEMNIFY, AND COVENANT NOT TO SUE the Edison Institute d/b/a The Henry Ford, Greenfield Village, their administrators, directors, agents, officers, members, organizers and volunteers, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place ("Releasees") FROM ALL LIABILITY, CLAIMS, LITIGATION, DEMANDS, LOSSES, OR DAMAGES TO MYSELF, MY GUESTS, MINOR CHARGES, OR ON OUR ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE RELEASEES OR OTHERWISE; AND WE FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT we, or anyone on our behalf, makes a claim against any of the Releasees, I/WE WILL INDEMNIFY, DEFEND, SAVE, AND HOLD HARMLESS, EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim or litigation.

**I HAVE READ THIS ELECTRONIC RELEASE AGREEMENT, FULLY UNDERSTAND ITS TERMS, AGREE THAT MY VIRTUAL SIGNATURE IS ACCEPTABLE AND BINDING ON ME AND BY PURCHASING TICKETS TO THIS EVENT, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.**
